WILL REPLACE WITHOUT CHARGE ANY GRANITE PART OF YOUR GUARDIAN MEMORIAL SHOULD THAT PART CRACK, CHECK, DISCOLOR OR PROVE DEFECTIVE IN ANY WAY ATTRIBUTABLE TO THE GRANITE OR WORKMANSHIP AND VERIFIED BY A REPRESENTATIVE OF GRANITE INDUSTRIES OF VERMONT, INC.** Such replacement and all related costs will be borne by Granite Industries of Vermont, Inc. and/or its retail dealers. This warranty in no way authorizes the party seeking warranty coverage to incur any expense toward replacement or related costs without prior written consent from Granite Industries of Vermont, Inc.
